# Letter From Board President Charlie Seltzer

I suppose it's my responsibility to leave you with farewell words—good cheer to tide you through the lonely years ahead. Well, you know me—never at a loss for words. So I offer you this vision for where you should go and how you should get there without me to guide you.

First, about this membership thing. Membership in the Billy community should be self-selecting: if you come to community events, you're a Billy. It's really quite simple. # Working Groups Manifest Vision by Bill Blackburn

The Billy men and kin who participated in the Visioning Retreat in mid-September determined that there are eight areas of focus requiring attention over the next several years to ensure our success as a community. We established Working Groups to determine what needs to be done in each area. Now we're asking you to consider joining one of these groups.

The success of the visioning process relies on fulfilling these tasks.

- 1) The Mission and Values Working Group will review our existing mission statement and our recently drafted values statement based on the feedback at the retreat and will refine them as needed. Decisions by the board, our gathering coordinators, and our outreach efforts will be based on these important statements. - 4) To help the Gathering Portfolio holder, Steve Rockwell, envision ways to make our gatherings more meaningful and fun, we're creating the **Juicy Gatherings Working Group**. To be part of this visioning process, contact **Steve Rockwell** at 415-553-8680 (home) or steve.rockwell@jud.ca.gov.
- 5) The Communications Working Group will identify ways to enhance communication between the board and the community and to support the Website Portfolio holder, Joe Kukulka, in improving the role, content, and usability of the website. - 6) The **Volunteerism Working Group** will help us find ways to locate and mentor more volunteers in the Billy community to lead our gatherings and take

- 7) Help invigorate our existing Fundraising Portfolio by joining the **Fundraising Working Group** to develop a comprehensive approach to fundraising that will ensure our continuing ability to keep gatherings as affordable as possible and make them accessible to those who are financially challenged.
